Criterion 1 – Organizational Framework (Curricular institutionalization): The institution's healthcare simulation-based education program has clear goals that are aligned with its organizational priorities and objectives, is systematically designed and serves the educational mission of the institution. For Example:

- Describe how your institution's program uses a systematic curriculum development model that is informed by a theoretical framework and best practices to design and implement simulation-based education.

This not only includes professionals trained in the best evidence use of simulation-based education, but also includes individuals involved in the operation, management, and administration of simulation-based training, and scholars dedicated to advancing the field. In addition,

- Provide evidence about how the institution's simulation program has faculty with expertise in carrying out simulation-based educational scholarship and supports their development by providing resources needed to achieve their goals and sustain their activity.


